# **Public Transport**

Traffic emissions along motorway corridors and busy main streets are affecting the health of our communities.

Continually investing in the roads network only leads to more cars on the roads and contributes to air pollution which claims thousands of lives in Scotland every year.



I submitted questions asking how the government plans to reduce pollutant levels to protect public health and also asked for it's stance on returning the railways to public ownership. I have also written to the transport commissioner on several occasions questioning the withdrawal of bus services and the lack of routes to help people travel to hospitals in Central Scotland.

In the Parliament I have asked the Scottish
Government whether it will review the powers of the (a)
Traffic Commissioner for Scotland and (b) public to take action against bus operators who fail to deliver agreed routes or withdraw or cancel services without advance notice.

In the Parliament I have asked the Scottish Government, in light of the finding that air pollution in central Scotland reached its worst level in three years on 17 March 2015 - largely due to car emissions according to environmental groups - how it will encourage individuals to use public transport.

# Fracking and Coal Gasification

Since the sale of drilling rights over a vast swathe of Central Scotland I have attended meetings and rallies opposing unconventional gas extraction and fracking and supporting the huge numbers of communities who oppose it.

I have submitted a series of questions to the Scottish Government. asking what their budget plan. and timetable is for the promised public consultation and health The impact assessments. answers received. some taking over six months to be fail provided, to decisive answers on this serious matter or to indicate if the government is simply delaying it's decision on



whether to allow fracking to go ahead until after the Holyrood and local governments elections.

It is clear that a large number of people are opposed to fracking taking place and the Government must, as promised, give them a platform to express their views.

In the Parliament I have asked the Scottish Government what its position is on concerns that it is purposely withholding substantive answers to questions regarding fracking and what action it is taking to allay these concerns.

### No to Trident

I have been a long term campaigner against nuclear weapons and against the huge danger of keeping a nuclear armed fleet of submarines at Faslane. The financial burden of Trident to a country struggling to maintain public services is beyond sense, the rising cost of replacement could be used to allow public services to recover from years of imposed austerity.



Nuclear weapons are a potential accident waiting to happen. That they are located in the central belt, Scotland's most populated area, cannot be allowed to continue. It is time to put an end to nuclear weapons once and for all.

## **Criminal Justice**


I have asked the Scottish Government if it will review it's commitment to tackling animal abuse, and for a register of judicial interests.



In the Parliament I have asked the Scottish Government, in light of the recent Scottish SPCA strategic review, which noted that the average fine for animal abuse is £139 and the average community service sentence is 3.2 days, what its position is on the need for stricter penalties for animal abusers.

# **Poverty and Welfare**

People have the right to a life free from poverty, and in a wealthy society like ours no-one should suffer hunger or be unable to heat their homes. Yet high rents, soaring utility bills, falling wages and insufficient welfare support leave many households without the money for basics like food and school uniforms. I will continue to fight against austerity and argue that the extensive cuts to the welfare of our most vulnerable is a political choice and not an economic necessity.



I have questioned the Scottish Government on what it plans to do to protect communities from Westminster's cuts to welfare and called for more powers to come to Scotland to tackle our high fuel poverty levels. I have also questioned the fact that only one in five of Scotland's largest companies pay their employees the living wage.

In the Parliament I have asked the Scottish Government how it will mitigate the effect of a reduction in tax credits and inwork support in order to prevent further increases in in-work poverty.

# **Local Democracy**

As a member of the public petitions committee I work to ensure that the Government is kept well informed of people's views and opinions on the many issues they face. Some of the issues people contact me about are to do with planning applications. Communities have the right to challenge planning decisions which impact on their health and wellbeing.

In the Parliament I have asked the Scottish Government what criteria it's reporters use when considering whether to overturn planning applications that have been previously rejected by local authorities.

In the Parliament I have asked the Scottish Government what consideration its reporter gave to the reported over 540 objections to the proposal from the public to Clean Powers Properties' application to build an incinerator in Hamilton.



Over recent months I have supported the community in Bellshill in opposing a new rail freight terminal which will take away valuable local greenspace; supported the community in Caldercruix in opposing the opening of a Super Quarry on their doorsteps and questioned the government on the planning application for a new incinerator in Hamilton.

## **Protect our NHS**

Our NHS service must be protected from privatisation and austerity cuts. From the emergency services to social care, hardworking staff are underfunded and unsupported due to budget cuts. The closure of out of hours centres, A&E waiting times, cuts to mental health services and the blurring of lines between free 'point of need' health care and social care which must be paid for are all issues which I have repeatedly taken up at the Parliament or directly with the Health Boards themselves.

NHS Lanarkshire has faced particular difficulties in managing to maintain service standards on it's limited budget, I have asked the Scottish government on many occasions how it plans to help the struggling service and in particular how the crippling burden of public finance initiative (PFI) debt can be removed from NHS service budgets.

In the Parliament I have asked the Scottish Government how it will redress the reported imbalance between NHS boards in wealthier areas having consistently shorter waiting times than those in less wealthy areas.

# Workers' Rights

As a long standing member of Unite, I will support workers and their representatives a cross Central Scotland as they stand against the appalling erosion of union rights, which Westminster intends to bring in with it's new Trade Union Bill.



I am a lifelong supporter of the rights of employees to have a safe working environment, earn a fair day's pay and have access to union representation. Worker protections are more important than ever when zero-hour contacts and low pay are leaving more children and young people living in poverty.

In the Parliament I have asked the Scottish

Government what progress local authorities have made in settling equal pay claims.

The recent increase of the living wage in Scotland to £8.25 per hour is a massive step in the right direction and I very much look forwards to the day when everyone regardless of age is paid a living wage.

# No to Special Relationships

The wheels of power have for too long been allowed to turn out of sight of public scrutiny, from council deals with arm's length external organisations to government dealings with large corporations I believe the public has the right to know what is being said behind the closed doors of the representatives who work for us.

I have campaigned for a register of lobbyists and believe that we must take a stand against the secretive international trade deals, such as TTIP, which aim to hand power to multinational corporations to allow them to override democratic decisions, worker protections and health regulations.



# **Community Projects**

I would like to thank all the community projects, voluntary organisations and charities I have had the pleasure of visiting, meeting or learning about this session.

I am always overwhelmed by the dedication of the volunteers I meet during my MSP visits, I myself volunteer on Sundays to assist elderly residents in my local area, and have absolute respect for the time and effort volunteers give when donating their time to their communities.
